

Online Privacy Notice

Scope and Consent

This Privacy Notice describes Denave's collection, use, disclosure, retention, and protection of your personal information. It applies to any Denave site where this Privacy Notice appears in the footer, and to any Denave application, service, or tool (collectively "Services") where this Privacy Notice is referenced, regardless of how you access or use them, including through mobile devices. **By using its Services and/or registering for an account with it, you are accepting the terms of this Privacy Notice and Denave's User Agreement, and you are consenting to its collection, use, disclosure, retention, and protection of your personal information as described in this Privacy Notice.** If you do not provide the information Denave require, it may not be able to provide all of our Services to you

If you reside in India, you are contracting with Denave India A-154/A 2nd Floor, Sector-63 Noida, Uttar Pradesh -201307. If you reside outside of India, you are contracting with one of Denave companies & Subsidiaries.

The company you are contracting with is your data controller, and is responsible for the collection, use, disclosure, retention and protection of your personal information in accordance with its global privacy standards as well as any applicable national laws. Your data controller may transfer data to other members of the Denave as described in this Privacy Notice. Denave may process and retain your personal information on their servers in India where its data centers are located.

Personal Information:

"Personal information" is information that can be associated with a specific person and could be used to identify that specific person whether from that data or from that data and other information that Denave has or is likely to have access to. Denave do not consider personal information to include information that has been made anonymous or aggregated so that it can no longer be used to identify a specific person, whether in combination with other information or otherwise.

Global Privacy Standards

Denave has established global privacy standards known as Binding Corporate Rules (BCRs). They are its commitment to protect your personal information and honor its privacy obligations regardless of where your personal information is collected, processed or retained within Denave. Denave's BCRs have been approved by European Union privacy regulators that means it is treating your personal information everywhere within Denave according to European Union privacy standards. Collection:

Denave collect, process, and retain personal information from you and any devices (including mobile devices) you may use when you: use its Services, provide it information on a web form, update or add information to your account, or when you otherwise correspond with it regarding their Services.

Personal information you give it when you use its Services or register for an account with it.

- Additional information Denave required or authorized by applicable national laws to collect and process in order to authenticate or identify you or to verify the information we have collected

Personal information we collect automatically when you use our Services or register for an account with us

- Geo-location information, including location information from your mobile device. Keep in mind that most mobile devices allow you to control or disable the use of location services by any application on your mobile device in the device's settings' menu

- Computer and connection information such as statistics on your page views, traffic to and from the sites, referral URL, ad data, your IP address, your browsing history, and your web log information

Personal information we collect using cookies, web beacons, and similar technologies

Denave use cookies, web beacons, unique identifiers, and similar technologies to collect information about the pages you view, the links you click, and other actions you take on its services, within our advertising or e-mail content. Use and Retention
